Founded by Sayer Ji, Dr. Edward Group, and Marla Maples, the Global Wellness Forum emerged from a shared understanding that fragmented efforts are no match for the scale and sophistication of today's disinformation landscape. The co-founders recognized the urgent need to unite principled, informed voices — to share rigorous research, elevate public understanding, and collectively amplify truth in the face of powerful forces working to obscure it.

GWF was created to harness the power of collective expertise, integrating research, legal analysis, and policy engagement into a focused, strategic platform. Its purpose is clear: to bring truth, health, and freedom into the public sphere — and to ensure transparency guides the decisions that shape our lives.

The Forum stands on a simple but powerful belief: when principled leaders act in coordination, truth gains strength, reform gains momentum, and lasting change becomes possible.

Dear Friend,

This year, the Global Wellness Forum has stood shoulder-to-shoulder with advocates, researchers, scientists, attorneys and policymakers to create the kind of change many once believed impossible. What began as a bold manifesto at our launch —calling for truth, transparency, and sovereignty in public health and environmental policy—has rapidly evolved into a powerful, coordinated movement. Together with our expert councils, strategic partners, and a rapidly growing national coalition, we transformed grassroots voices into policy influence, public awareness, and legislative victories.

We were founded on a shared vision: a world where public policy serves the people, not profit; where science is guided by ethics and integrity rather than industry influence; and where every individual can live in sovereignty, health, and harmony with nature. That vision has been our compass as we built an organization capable of elevating truth-tellers, supporting whistleblowers, commissioning research, mobilizing citizens, and engaging lawmakers at every level of government.

In just our first year, GWF built a robust expert council network of more than ten councils and over fifty distinguished leaders spanning science, medicine, law, and ethics. We helped advance landmark state-level reforms—from Florida's historic bill to criminalize geoengineering and weather modification, to fluoride removal efforts, to the growing national movement for psychological rights. We launched major public-education initiatives, released influential white papers, conducted environmental weather analyses, and held briefings with state legislators and federal policymakers. And through media engagement, interviews, and national platforms, we brought critical visibility to issues long kept in the shadows.

Our partnerships have deepened across more than twenty aligned organizations, allowing us to coordinate research, advocacy, content-sharing, and coalition work in service of a shared mission. By coordinating closely with aligned organizations, we not only expand the impact of shared initiatives but also help set the direction for national conversations. GWF's leadership in messaging and mobilization has become a catalyst for the broader movement's momentum.

GWF now serves as a trusted expert resource for key national health leaders, offering substantive white papers, scientific research, and investigative reports to support the administration's efforts to restore integrity, transparency, and evidence-based decision-making. We have briefed senior officials, contributed to policy evaluations, and advanced aligned initiatives such as Make America Healthy Again. In parallel, we strengthened a multi-organization coalition dedicated to protecting psychological rights and contributed to international conversations—including the launch of Make Europe Healthy Again in Brussels and Codex food-integrity discussions abroad earlier this year in North Korea. These contributions underscore GWF's role as both a national thought leader and an emerging presence in global wellness governance.

As we look ahead, our mission remains clear: to unite truth-tellers, support scientific integrity, empower citizens, and hold leaders accountable. We will continue expanding our expert research, strengthening our existing councils, coordinating national coalitions, and advancing policy reform to create a new standard for wellness—one rooted in transparency, dignity, and respect for all life. The momentum we have built is only the beginning.

We invite you to join us not as observers, but as participants—because the future we seek is not inherited; it is built by the choices we make and the actions we take today.


### POLICY REFORM & LEGISLATIVE ACTION

Strengthening grassroots leadership and local wellness infrastructure for self-sufficiency, resilience, and connection.




# GWF 2025 BY THE NUMBERS

## COALITION BUILDING & FOUNDATIONAL POLICY WORK

- Expanded GWF's Expert Councils to more than 50 interdisciplinary leaders, strengthening scientific, legal, and clinical capacity.
- Delivered expert data, white papers and briefings to federal and state governmental officials on weather modification and geoengineering including toxicity and health impacts.
- Provided key statehouse testimony in Florida guiding reforms on toxic exposures, medical ethics, and environmental health.
- Began national mobilization efforts around geoengineering, building a coordinated network of experts and citizen advocates.
- Sayer Ji brought GWF's mission across the globe as a participant in the 2025 Codex Alimentarius in North Korea, advocating for health, informed consent and food sovereignty.

## STATE-LEVEL MOMENTUM & PUBLIC AWARENESS

- Released a series of white papers and scientific summaries that informed legislative drafting and agency-level discussions.
- In partnership with Stand for Health Freedom, supported Florida's successful decision to remove fluoride from public water systems, marking a major win for transparency and community health.
- GWF was instrumental in securing the nation's first state-level ban and criminalization of atmospheric weather-modification activities—a milestone that sparked nationwide conversations and replication efforts.

## LANDMARK LEGISLATIVE WINS

- Conducted high-impact briefings or submitted research and white papers to state and federal agencies, elevating scientific evidence and policy recommendations on a number of topic areas: geoengineering, autism related research and other areas related to reducing toxic exposures.
- Launched a national Psychological Rights Coalition, bringing together policy experts, attorneys, advocates, and strategic partners to address coercive or harmful mental-health practices, specifically to address electroconvulsive shock therapy.
- Expanded partnership network to 20+ aligned organizations, creating a durable infrastructure for coordinated advocacy in 2026 and beyond.

## GLOBAL VISIBILITY, MEDIA AMPLIFICATION & MOVEMENT GROWTH

- Achieved significant national and international media visibility, including major network interviews, documentary features, and expert commentary segments that reached millions of viewers on a variety of topics including geoengineering, links to autism, unraveling foreign-interest led censorship and special interest groups disinformation campaigns and more.
- Drove unprecedented public engagement on geoengineering, toxic exposure, and health sovereignty issues across social platforms—helping place these topics in the national policy arena.
- Established GWF as a trusted policy resource by formalizing research-to-action pipelines that translate scientific findings into legislative language, regulatory recommendations, and public education tools.
- Sayer Ji joined the Make Europe Healthy Again (MEHA) leadership team to help them launch MEHA at the European Parliament and was a participant for this groundbreaking event.

In 2025, GWF advanced public health, environmental integrity, and individual rights through policy reform, legislation, scientific research, and grassroots mobilization.

- **Fluoride Removed in Florida:** Supported & collaborated with Stand for Health Freedom to pass the successful statewide ban of fluoride from public water systems.
- **First State Ban on Geoengineering:** Helped secure the nation's first criminalization of weather-modification practices.
- **National Awareness Sparked:** Elevated geoengineering into mainstream policy dialogue through media, expert commentary & influencer amplification.
- **Psychological Rights Coalition Launched:** Formed a national coalition to protect individuals from coercive mental-health practices.
